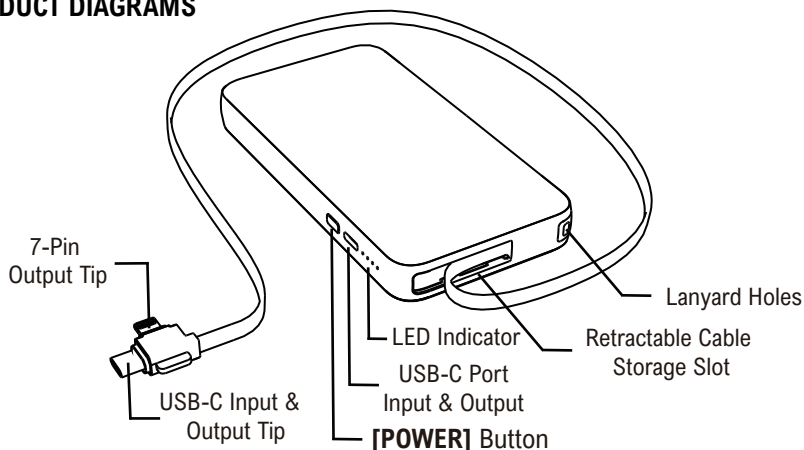
When using this product, basic precautions should always be followed, including the following:

- a) Read all the instructions before using the product.
- b) To reduce the risk of injury, close supervision is necessary when the product is used near children.
- c) Do not put fingers or hands into the product.
- d) Do not expose power bank to rain or snow.
- e) Use of a power supply or charger not recommended or sold by power pack manufacturer may result in a risk of fire or injury to persons.
- f) Do not use the power bank in excess of its output rating. Overload outputs above rating may result in a risk of fire or injury to persons.
- g) Do not use the power bank that is damaged or modified. Damaged or modified batteries may exhibit unpredictable behavior resulting in fire, explosion or risk of injury.
- h) Do not disassemble the power bank. Take it to a qualified service person when service or repair is required. Incorrect reassembly may result in a risk of fire or injury to persons.
- i) Do not expose a power pack to fire or excessive temperature. Exposure to fire or temperature above 100°C may cause explosion. The temperature of 100°C can be replaced by the temperature of 212°F.

INSTRUCTIONS

Charge the power bank fully before using for the first time.

CHARGING THE POWER BANK

- Plug the USB-C tip of your own charging cable into the USB-C port on the power bank. Plug the other end of the cable into a USB power source, such as the USB port on a computer or into a certified USB adapter (not included), and plug into a wall socket.
- Or plug the integrated cable with USB-C Tip into a USB-C power source, such as the USB-C port on a computer or into a certified USB-C adapter (not included), and plug into a wall socket.
- The LED indicator will **flash WHITE** while power bank is in charging and stop flashing when the power bank is fully charged.

CHARGING ELECTRONIC DEVICES WITH THE POWER BANK

- Pulling the retractable integrated cable out of the power bank, connect the charging cable to your device with the appropriate connector.
- Or plug the USB-C tip of your own charging cable into the USB-C Port on the

power bank. Plug the other end of the cable into your device with the appropriate connector.

- The power bank will begin to charge automatically.
- The LED indicator will **illuminate WHITE** when charging.
- Remove the cable from the charged device when it is fully charged.
